In course of this MoU, both the parties to MoU mentioned above have been individually referred to as "Party" and jointly as "Parties".

WHEREAS, **VKG Bajaj, Yadagiri** is working as a dealer of Bajaj bikes. The main intent behind this initiative is to better equip young Management students and to increase their awareness in Automobile industry. Company has taken an initiative to develop certain skills in certain specializations; they can be productive and able to provide solutions to the real world problems.

WHEREAS, **SLNCE** strives to serve as a center for fostering co-operation and exchange of ideas between the academic and research community on one hand and the industrial and Governmental employers on the other hand; and to promote entrepreneurship among the students & to co-operate with industries both in public and private sectors with a view to design courses of instruction which would meet the requirements of such industries.

Terms and Conditions

1. **VKG Bajaj, Yadagiri** imparts training to students and faculty of the college and professionals working in the field during the mutually convenient period either at the institution or at the Industry.
2. Collaborated activities between the industry and the institution include two way transfer of information and knowledge through collaborative programs like guest lectures, seminars, symposia, workshops, Project Work and other interactive programs. Deputation of technical experts/staff between the college and company is also inclusive.
3. Participation in joint funded research projects and public sector units, participation of joint consultancy, promote and support innovative projects undertaken by students and staff of both parties.
4. **SLNCE** commits to make available the students, professors, training rooms and required hardware resources during the program as may be required.
5. **VKG Bajaj, Yadagiri** may be given the opportunity to the qualified management students to attend campus interviews however subjected to the recruitment plan/policy of the company.
6. In order to assess the impact of the program on the student's career, company requires details about the student's after graduation in terms of placement and higher-education. The college management agrees to provide this data and all support required to capture this information to company.
7. Proprietary information disclosed by the company in the course of discussions and training under this MoU shall be kept highly confidential. College shall not use company's name or its trademarks or make any reference to the MoU or the program in any manner of publicity without company's prior written consent.
8. **SLNCE** is aware that the business activities of company are self-regulated by the "Company Code of Conduct" which is incorporated by reference herein.
9. This MoU is effective from the date of signing and will remain valid for 6 years unless terminated by either Parties, upon thirty (30) days written notice to others Party.
