This Memorandum of Understanding (MoU) is entered amongst Department of Electronics and Communication Engineering, HKE Society's S.L.N College of Engineering, (hereinafter referred to as "SLNCE"). The college was established in 1979 with its campus at Yeramarus Camp, Raichur, Karnataka 584 135.

And

**PNN Technologies**, (Hereinafter referred to as "**PNN Technologies**") situated at Bengalooru.

In course of this MoU, both the parties to MoU mentioned above have been individually referred to as "Party" and jointly as "Parties".

**WHEREAS, PNN Technologies** is a software developing and marketing company, established in the year 2015 at Malleshwaram in Bangalore under the companies' act of 2005. A target oriented company with budding/incipient ideas and excellent/vibrant talent benefiting people of all ages and phases in the society that concentrates on products and services which are of social benefit. Its vision is to expand "knowledge" which is valued the most, as it is an integral part of our lives. The designers here design various sorts of websites and strive to meet everyone's requirements.

**WHEREAS, SLNCE** strives to serve as a center for fostering co-operation and exchange of ideas between the academic and research community on one hand and the industrial and Governmental employers on the other hand; and to promote entrepreneurship among the students & to co-operate with industries both in public and private sectors with a view to design courses of instruction which would meet the requirements of such industries.



**AND WHEREAS,** both the parties have expressed a common interest in providing industry relevant training to the Engineering students, enhance their awareness, expand their industry connect and in the process, increase their employability.

The parties intend to enter in to this MoU to provide a frame work as per below terms and conditions to evaluate the area of collaboration between them and establish certain rights and obligations between the parties during such evaluation.

### **Terms and Conditions**

1. **PNN Technologies** Company imparts training to students and faculty of the college and professionals working in the field during the mutually convenient period either at the institution or at the Industry.
2. Collaborated activities between the industry and the institution include two way transfer of technical information and knowledge through collaborative programs like guest lectures, seminars, symposia, workshops and other interactive programs. Deputation of technical experts/staff between the college and company is also inclusive.
3. Provide access to knowledge resources at the institution and the industry. Utilize with consent the laboratory and testing facilities available at the institute/industry for the execution of joint ventures/activities. Provide technical assistance/guidance to UG projects undertaken and research work of mutual interest. Also provide lecturing capturing system to be used for video recording of the staff members of SLNCE.
4. Participation in joint funded research projects and public sector units, participation of joint consultancy, promote and support innovative projects undertaken by students and staff of both parties.
5. **SLNCE** commits to make available the students, professors, training rooms and required hardware resources during the program as may be required.
6. **PNN Technologies** may be given the opportunity to the qualified engineering students (who also fulfill the selection criteria set out by HR, **PNN Technologies**) to attend campus interviews however subjected to the recruitment plan/policy of the company.
7. In order to assess the impact of the program on the student's career, company requires details about the student's after graduation in terms of placement and higher-education. The college management agrees to provide this data and all support required to capture this information to company.
8. Proprietary information disclosed by the company in the course of discussions and training under this MoU shall be kept highly confidential. College shall not use company's name or its trademarks or make any reference to the MoU or the program in any manner of publicity without company's prior written consent.
9. **SLNCE** is aware that the business activities of company are self-regulated by the "Company Code of Conduct" which is incorporated by reference herein.
10. This MoU is effective from the date of signing and will remain valid unless terminated by either Parties, upon thirty (30) days written notice to others Party.
